SCORING and KEY: Each “X” is worth one point, out of a total of ten. However, any state who has failed to enact the most basic law on sex trafficking or labor trafficking will be deducted one point for each. An asterisk(s) is worth a “+” or ½ point.

*Pilot program in effect in some counties ** Provides for forfeiture of vehicles used in prostitution of minors. ***Considered an enhancement only for sentencing purposes. + Legislation suggests or encourages practice, but does not mandate.
